RATE DESIGNATION: Rider 6B - Cost of Gas Adjustment

CLASS OF SERVICE: ALL SCHEDULES SO DESIGNATED

SERVICE AREA: -----

In the event that the commodity cost of natural gas as purchased from a pipeline company or companies is increased or decreased, on or after the effective date hereof, under the jurisdiction of a duly constituted regulatory body (whether or not charged for under bond) such increase or decrease in commodity cost shall be added to or deducted from the rate as stated.

When increased commodity costs are added to Customers bills under the provisions of this rider and subsequent refunds, including interest thereon, if any, are made to the Company by the pipeline company or companies applicable to the commodity cost of gas, then the Company shall determine the amount of refund applicable to each Customer's purchase of natural gas from the Company under this rate schedule and make the appropriate refund to such Customers.

For each twelve month period ending with the June bill month, an annual cost reconciliation by cost component for each rate will be determined based upon actual annual gas costs incurred by Interstate compared with annual gas costs recovered from volumes of gas sold. The annual gas cost recovered by cost component is the sum of gas cost recovered through base rates and gas cost recovered through PGA factors. The difference between actual cost and recovered cost for each component will be used in calculating a Gas Cost Reconciliation (GCR) factor for each rate schedule. The GCR factor will be applied to customers' usage on September 1 and will be in effect for a twelve (12) month period.
