1. Account Number

Your 10-digit account number.

2. Due Date

Date your bill amount is due.

3. Amount Due

Amount that is due for this month's bill.

4. Contact Us

Phone number, website or PO Box if you need to reach us.

5. Message Board

Helpful information about easy ways to manage your account and save energy or money.

6. Energy Usage

Compare your usage this month to the previous 13 months.

7. Degree Days

Energy consumption indicator, based on the average outdoor temperature.

8. Meter Readings

Reading obtained either remotely or manually from your meter at the time of billing. An 'estimated' next to either number denotes that the read for that month was estimated.

9. Meter Multiplier

Factor that is multiplied against the difference between the previous meter reading and the present reading to obtain the actual energy consumption. The multiplier is specific to the meter and how it is programmed.

10. Electric Units Billed (kWh)

Number of electricity units used in a reading period. One kWh is the amount of power to use a 40-watt light bulb for 25 hours.


Natural Gas Units Billed (therms)

Measured by volume, CCF (100 cubic feet).

12. Heat Factor Adjustment

The amount of heat in each CCF of gas can vary, so the Heat Factor Adjustment compensates for any differences, and converts units to therms. Billing in therms assures you receive an equal amount of heat from each unit billed.

1. Energy Charge

Kilowatt hours (kWh) used per billing period. Rate (or price) for energy generation and distribution.

2. Fuel Adjustment

This cost, billed per kWh used, is an additional charge that may be required to accommodate for changes in fuel prices.

3. Statewide Low Income Assistance Fee

Fee set by Department of Administration and varies by customer class. Fee is capped at 3% of total bill and passed to the state of Wisconsin to administer energy efficiency and utility bill payment assistance to low-income customers.

4. Customer Charge

The customer charge covers the cost of operations to supply and maintain your utility service. This charge includes items like meters, other equipment, and account administration. The customer charge for each utility service is billed monthly.

5. Tax

This includes state tax and county tax if applicable.

1. Rate

Tariff that details service charges.

2. Distribution Charge

Recovers some of the fixed and variable costs of providing service.

3. Gas Supply Base Rate

Recovers the cost of natural gas itself and the rate is set in a rate case proceeding before the Public Service Commission of Wisconsin.

4. Gas Supply Acquisition Charge

Carrying cost of gas and storage.

5. Gas Supply Market Adjustment

Actual cost of natural gas fluctuates daily and this adjusts the "Gas Supply Base Rate" to the actual market price for natural gas.

6. Customer Charge

Covers the cost of operations to supply and maintain your utility service. This charge includes items like meters, other equipment, and account administration. The Customer Charge for each utility service is billed monthly.

7. Tax

Includes state and county tax if applicable.
