



COMMERCIAL ELECTRIC-CAPABLE TRANSPORT REFRIGERATION UNIT 2021 REBATE CLAIM FORM

To be eligible for this rebate, you must:

- Be a nonresidential Alliant Energy electric customer whose account is in good standing
- Purchase or lease an electric-capable transport refrigeration unit [eTRU] and install the necessary infrastructure to plug-in the eTRU between January 1, 2021 and December 31, 2021.
 - eTRU must meet one of the following conditions:
 - Replacement of internal combustion unit(s)
 - Expansion of an existing fleet
 - The first eTRU(s) at the facility
- Provide valid, dated equipment receipt(s), invoice(s) and lease agreement (if applicable) for all eTRUs and electric plug-in infrastructure installed
 - eTRUs or electric plug-in infrastructure replacing existing eTRUs or existing plug-in infrastructure does not qualify
 - Leased or used eTRUs may be eligible for a rebate with approval from Alliant Energy
 - Only three-phase power, 480-volt eTRUs qualify for a rebate (smaller eTRUs may qualify for a reduced rebate incentive with approval from Alliant Energy)
 - Infrastructure may include the necessary wiring, contractor fees, breakers, individual electrical outlets at each parking bay, and any other typical infrastructure that is necessary to provide power to the eTRU

REBATE TERMS AND CONDITIONS

This rebate covers up to **\$1,500** for the purchase/lease and installation of a new 480-volt eTRU and electric infrastructure necessary to plugin the eTRU at a facility whose electric service meter is billed under a nonresidential Alliant Energy electric rate. Alliant Energy highly recommends that all associated plug-in infrastructure be installed by a licensed electrician and in accordance with all applicable codes and permitting procedures, as mentioned in more detail in the terms and conditions listed below. Alliant Energy is offering a limited number of these rebates. Availability is subject to overall participation levels. Customers are responsible for checking with Alliant Energy to determine whether funding is available and to verify program parameters. Further, Alliant Energy reserves the right to cancel or modify these rebate programs at any time in its sole discretion.

Electric-Capable Transport Refrigeration Unit Eligibility Restrictions:

- Only nonresidential Alliant Energy electric customers whose accounts are in good standing are eligible for the rebate.
- Rebates are only available for eTRUs and infrastructure typical and necessary for plugging in eTRUs.
- Rebates are only available to Alliant Energy electric customers who are end-users of eTRUs (i.e., rebates are not available to eTRU vendors and/or dealers, or to a third-party installers of plug-in infrastructure).
- This rebate applies to eTRUs and plug-in infrastructure purchased or leased and installed between January 1, 2021 and December 31, 2021.
- Each eTRU must meet one of the following conditions: replacement of internal combustion unit(s), expansion of an existing fleet, or the first eTRU at the facility.
- Only three-phase power, 480-volt eTRUs qualify for rebate program (smaller eTRUs may qualify for a reduced rebate incentive with written approval from Alliant Energy).
- eTRUs or electric plug-in infrastructure replacing existing eTRUs or existing plug-in infrastructure does not qualify.
- Leased or used eTRUs may be eligible for a rebate with approval from Alliant Energy.
- eTRUs gifted, donated or won as part of a raffle or giveaway are not eligible.
- Projects must demonstrate permanency.
- Invoice(s) and lease agreement(s) (if applicable) must be dated and itemize labor charges (if applicable), quantity, and price, as well as information regarding the manufacturer, model, and serial number(s) of all equipment included in the rebate.
- All city, county, or state government, property owner or business association rules, codes, and regulations must be complied with during the installation of the eTRU plug-ins. All necessary permits must be obtained prior to installation.

Failure to comply with any foregoing requirements could result in denial of any rebate awards.

Alliant Energy reserves the right to audit your installation.

Alliant Energy reserves the right to randomly select your business for an on-site audit to verify the installation of the rebated eTRU equipment or infrastructure purchased at your facility. You hereby consent to such an audit and you agree to grant Alliant Energy access to your premises or property, to the extent reasonably necessary to conduct such an audit. If your rebate is selected for a field audit, you will be contacted by an Alliant Energy representative and grant reasonable access to the installation site during normal business hours or as otherwise agreed between you and Alliant Energy. If the field audit discovers that the eTRU equipment or infrastructure does not comply with the rebate claim form, then the customer's rebate award(s) may be rescinded.

Alliant Energy is not responsible for the operation or failure of equipment.

Alliant Energy is not a party to any sales or lease transaction between you and the manufacturer and/or dealer. Alliant Energy's liability and responsibility in connection with the Electric-Capable Transport Refrigeration Unit Rebate Program shall be strictly limited to the making of certain rebate payments for eligible equipment, and Alliant Energy does not make, will not provide and specifically disclaims any and all representations, warranties, covenants or guaranties whatsoever, express or implied, in connection with the eTRUs or the program itself, including, without limitation, the implied warranties of merchantability and fitness for a particular purpose. Alliant Energy shall in no way be liable or responsible for any equipment installed by or for any act or omission of, any other entity or individual, including, without limitation, the equipment manufacturer, dealer, supplier or any electrician, technician, or other service provider.

Alliant Energy reserves the right to contact you as part of its program evaluation activities.

Customers and dealers participating in the Electric-Capable Transport Refrigeration Unit Rebate Program may be contacted to participate in Alliant Energy's study of electrotechnology plug-in practices to better understand electrotechnology users' plug-in practices and preferences, improve electrotechnology services, and encourage greater electrotechnology deployment.
