

COMMERCIAL/COMMUNITY/MULTIFAMILY ELECTRIC VEHICLE (EV) CHARGING STATION REBATE CLAIM FORM

INSTRUCTIONS: Fill out form completely and sign. **Attach required documentation: Itemized receipt(s) or invoice(s) and a W-9 form.** Failure to complete the form and provide documentation will result in claim being sent back or denied. For the terms and conditions of this rebate program, please see page 2 of this form.

Multifamily housing buildings have common spaces and are either three vertically-stacked units or have four or more units. Buildings with three or fewer collinear units are defined as single family. This rebate is for Level 2 EV charging stations installed in common spaces only; single family buildings may be eligible for residential rebates.

To be eligible for this rebate, you must:

- Be a nonresidential Alliant Energy electric customer whose account is in good standing.
- · Have your networked Level 2 EV charging station connected to an electric meter billed under a nonresidential Alliant Energy electric service rate.
- Purchase and install an Energy Star, Underwriters Laboratories (UL) or Electrical Testing Labs (ETL) certified networked Level 2 EV charging station between Jan. 1, 2022, and Dec. 31, 2022, available for employee, tenant and/or guest use.

Program participation requires consent for random on-site audits and review of usage data.

The rebated amount for the electric vehicle charging station will be the lesser of: (1) \$1,500 for a dual-port (networked*) unit (charges two cars), (2) \$1,000 for a single-plug (networked*) unit (charges one car) or (3) the electric vehicle charging station equipment cost listed on the included receipt, less shipping, handling, sales tax and any accessories to the unit itself.							
If more than two rebates are requested per location, prior approval documentation must accompany this form.							
*A Networked Level 2 EV charging station, sometimes referred to as a "smart" charging station, must be capable of connecting to the internet via Wi-Fi or cellular connection for app or web-based charging control, data access and station management.							

This Electric Vehicle Charging Station Rebate covers the lesser of: (1) \$1,500 for a dual-plug (networked*) unit (charges two cars), (2) \$1,000 for a single-plug (networked*) unit (charges one car) or (3) the electric vehicle charging station equipment cost listed on the included receipt, less shipping, handling, sales tax and any accessories to the charging unit itself. Charging stations must be installed at a business whose electric service meter is billed under an Alliant Energy nonresidential electric rate. Alliant Energy highly recommends that all Level 2 EV charging stations be installed by a licensed electrician and in accordance with local municipal codes and permitting procedures as mentioned in more detail in the terms and conditions listed below. Alliant Energy is offering a limited number of these rebates, so availability is subject to overall participation levels. Alliant Energy reserves the right to cancel or modify this rebate program at any time at its sole discretion. Participating customers are required to provide Alliant Energy access to station data, for no less than 5 years, by naming Alliant Energy as a network administrator (with access to data only) through the station commissioning process.

Electric vehicle charging station eligibility restrictions:

- · Only commercial customers whose nonresidential electric service accounts are in good standing are eligible for the rebate.
- Rebate available only for networked Energy Star, UL or ETL certified Level 2 (240-volt) electric vehicle charging stations or the installation costs associated with installing new Energy Star, UL or ETL certified chargers.
- Alliant Energy recommends the purchase and installation of Energy Star certified electric vehicle chargers.
- This rebate applies to new Level 2 electric vehicle charging stations purchased and installed between Jan. 1, 2022, and Dec. 31, 2022.
- Used, refurbished or rented electric vehicle charging stations are excluded from this rebate.
- · Electric vehicle charging stations discounted, gifted or won as part of a raffle, giveaway, grant or other discounted program do not qualify for this rebate.
- Projects must demonstrate permanency.
- Rebate application must be USPS postmarked on or before Jan. 31, 2023, to qualify for the rebate. Applications submitted after the deadline will not be accepted.
- · No more than two rebates may be paid to each Alliant Energy customer without prior approval provided funding is available.
- · All city, county or state government, property owner or homeowner's association rules, codes and regulations must be complied with during installation of the EV charging station.
- All necessary permits must be obtained prior to installation.
- Alliant Energy is offering a limited number of rebates. Availability is subject to overall participation levels. Alliant Energy reserves the right to cancel or modify this rebate program at
 any time at its sole discretion. Submission does not guarantee inclusion in this program.

Failure to comply with any of the foregoing requirements could result in denial of any rebate.

Alliant Energy reserves the right to audit your installation.

Alliant Energy reserves the right to randomly select your building for an on-site audit to verify the installation of the rebated electric vehicle charging equipment installed at your business. You hereby consent to such an audit, and you agree to grant Alliant Energy access to your premises or property to the extent reasonably necessary to conduct such an audit. If your installation is selected for a field audit, you will be contacted by an Alliant Energy representative to schedule an appointment. By signing and submitting this rebate claim form, you agree to provide an Alliant Energy representative reasonable access to the installation site during normal business hours or as otherwise agreed between you and Alliant Energy. If the field audit discovers that the equipment has not been installed as indicated on the rebate claim form, then the customer's rebate may be rescinded.

Alliant Energy is not responsible for the failure of installed equipment.

Alliant Energy is not a party to any sales transaction between you and the manufacturer and/or dealer. Alliant Energy's liability and responsibility in connection with the Electric Vehicle Charging Station Rebate Program shall be strictly limited to the making of certain rebate payments for eligible equipment, and Alliant Energy does not make, will not provide and specifically disclaims any and all representations, warranties, covenants or guaranties whatsoever, express or implied, in connection with the electric vehicle charging station or the program itself, including, without limitation, the implied warranties of merchantability and fitness for a particular purpose. Alliant Energy shall in no way be liable or responsible for any equipment installed by, or for any act or omission of, any other entity or individual, including, without limitation, the equipment manufacturer or any electrician, technician or other service provider.

Alliant Energy reserves the right to contact you as a part of its EV market research and program evaluation activities.

Customers participating in the Electric Vehicle Charging Station Rebate Program may be contacted to participate in Alliant Energy's study of EV charging practices to better understand EV drivers' charging practices and preferences, improve EV services, and encourage greater EV deployment.
